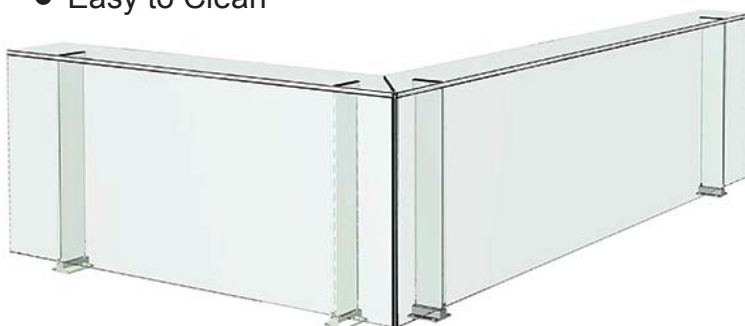

Class: Partition - Food Shield / Sneeze Guard - (vertical shield with mini 6" top shelf)

Model C408 is part of the Crystalline Series featuring the elegant all glass look. The C408 represents a family of free-standing partition food shields (sneeze guards) assembled using CRG construction. These partitions have a vertical shield and a mini 6" top shelf. The only hardware on these units are the flanged boot for counter attachment. There are four standard heights, eight standard widths, and comes in 1/4", 3/8", or 1/2" safety tempered glass. The C408 is a quick and easy way to meet your sneeze guard requirements. NSF Cafeteria Food Shield regulation (5.35.5.1) states the sum of the vertical and horizontal measurements need to be $\geq 24"$. The C408 top shelf contributes to the overall height requirement. Custom sizes available. Always review your sneeze guard plans with your health department.
